

ACCESS TO ESSENTIAL SERVICES WAS CREATED TO ADDRESS A LACK OF EFFECTIVE SERVICES AVAILABLE TO IMMIGRANTS AND FARMWORKERS IN WASHINGTON COUNTY THAT PREVENTED THESE COMMUNITIES FROM MEETING BASIC NEEDS OR PURSUING LONG-TERM GOALS. THE AIM OF THIS PROGRAM IS TO ENSURE THAT COMMUNITY MEMBERS HAVE THE OPPORTUNITY, RESOURCES, AND CONNECTIONS TO SETTLE, THRIVE, AND PARTICIPATE IN THEIR COMMUNITIES ACROSS DOWNEAST MAINE. FOR EXAMPLE, IN MILBRIDGE, WE OFFER SIX UNITS OF AFFORDABLE HOUSING FOR FARMWORKERS AT HAND IN HAND APARTMENTS, WHICH HOUSED 22 PEOPLE IN 2018. THROUGH AN ANONYMOUS DONOR, WE ALSO AWARD \$20,000 IN COLLEGE SCHOLARSHIPS EACH YEAR. ADDITIONALLY, OUR FALL WELCOME AND RESOURCE CENTER EVENTS SERVED APPROXIMATELY 500 MIGRANT AND SEASONAL WORKERS

MANO EN MANO PROVIDES SERVICES TO MIGRANT CHILDREN AND YOUTH ACROSS MAINE THROUGH A PARTNERSHIP WITH THE MAINE MIGRANT EDUCATION PROGRAM (MEP) AND TITLE I, PART C OF THE ELEMENTARY AND SECONDARY EDUCATION ACT. THIS PROJECT SERVES MIGRANT CHILDREN AND YOUTH FROM BIRTH THROUGH AGE 20 WITH THE GOAL OF ENSURING THAT MIGRANT STUDENTS ARE ABLE TO MEET THE SAME CHALLENGING ACADEMIC STANDARDS AS NON-MIGRANT STUDENTS (ULTIMATELY EARNING A HS DIPLOMA OR GED).
